# JOINT STATEMENT REGARDING THE REPORT TO CONGRESS OF THE DEPARTMENT OF JUSTICE INSPECTOR GENERAL ON THE FBI'S USE OF NATIONAL SECURITY LETTERS AND EX PARTE ORDERS FOR BUSINESS RECORDS MARCH 9, 2007

On March 5, 2007, Attorney General Alberto Gonzales called Board Chairman Carol E. Dinkins to inform her that the Department of Justice's Inspector General would shortly release a report to Congress on the FBI's use of National Security Letters (NSLs) and ex parte orders for business records. This report is required by the USA Patriot Improvement and Reauthorization Act of 2005 ("USA PATRIOT Act", Public Law 109-177). The Attorney General asked that the Board be briefed on the Inspector General's findings and how the department intended to respond to his recommendations. He also encouraged the Board to conduct any additional review and provide comments, as it deems appropriate.

The following day, the Board was briefed by, and had the opportunity to question, the FBI General Counsel and Chief Privacy Officer, and staff of the Department of Justice National Security Division and the Chief Privacy and Civil Liberties Officer. In order to obtain his perspective, Chairman Dinkins has spoken with Inspector General Glenn A. Fine and requested a meeting with him so that he may present the report's findings and recommendations directly to the Board.

In June 2006, the Board agreed that one of its priorities would be to closely monitor implementation of provisions of the newly reauthorized USA PATRIOT Act, which included over 30 new civil liberties protections. The Board tasked Member Lanny Davis to lead this effort. On November 17, 2006, he received an initial briefing by staff of the National Security Division. The full Board appreciates this additional opportunity to review the activities of the FBI, as authorized by the USA PATRIOT ACT, to ensure that privacy and civil liberties protections are appropriately considered and adequately followed as it fulfills its critical mission in protecting the Nation against terrorism.

The Board does not intend to discuss this matter publicly until its review is complete.
