Appendix 6 - Other Hour Reductions by Counsel

The following table sets forth additional hour reductions for particular tasks or activities set forth in the respective counsel's fee request. The grounds for these reductions are set forth in Defendants' Opposition to Plaintiffs' Motion for Attorney Fees and/or briefly noted in the entry. The reductions described in this appendix are for hours that Defendants submit are either unproductive, unnecessary, excessive, or otherwise unreasonable. In addition, entries in counsel's declaration that are too vague to support any compensation are also identified and reduced or eliminated.

The reductions set forth in the following tables are distinct from reductions set forth in Appendix 5 for duplication by counsel. In general, if Defendants' position is that an activity listed in Appendix 5 should be reduced further or eliminated, the further percentage reduction is limited to 50%. If the activity or entry is not identified in Appendix 5, the reductions set forth in these tables are made by estimating the hours for the activity (generally by dividing the hours in a block of time by the number of activities or subjects identified in the block) and then reducing the hours by the percentage indicated.
