

This report covers the period from 1 July - 30 September 2009 and is submitted pursuant to direction dated 17 July 2008 from the Director of National Intelligence and the Chairman of the Intelligence Oversight Board (IOB) and the accompanying "Criteria on Thresholds for Reporting Intelligence Oversight Matters."
During this reporting period, the Central Intelligence Agency (CIA) Office of Inspector General (OIG) learned of no intelligence activities that were potentially unlawful or contrary to executive orders or Presidential directives. OIG did receive an allegation of reprisal by a senior Agency official. The case alleges that the Director of the National Clandestine Service (NCS) took action recalling a subordinate officer in an overseas location short of tour. The subordinate officer had recently provided information to this office. OIG's investigation has established that the action of the NCS Director was in accordance with law and regulation.
The OIG participated in an Intelligence Community-wide review of the President's Surveillance Program (PSP) and published a comprehensive PSP report to the appropriate committees of the Congress in July 2009, fulfilling the Title III of the Foreign Intelligence Surveillance Act Amendments Act of 2008 requirement.
